#### SOLVENTS: a wide variety of uses

- Solvents are liquids that have the ability to dissolve, suspend or extract other materials.
- Solvents make it possible to process, apply, clean or separate materials.
- There are many different kinds of solvents with a variety of properties (viscosity, dissolving power, evaporation rates, etc) that determine their use for each application.
- There is a large demand for solvents from many different industry sectors, with the largest coming from the paint and coatings industry.
- Solvents have become invaluable to the pharmaceutical industry, as they are essential for achieving the purity required of modern medicines – to name just one example.

#### SOLVENTS: a responsible approach to safety, health and environment

- All solvents produced by ESIG members have been thoroughly tested for their health, safety and environmental properties.
- The European solvents industry is committed to complying with and even exceeding the EU's health, safety, and environmental (HSE) requirements.
- Maintaining the highest levels of safety and health standards is an absolute priority. This is achieved by conducting continuous scientific research and development to improve products and by providing health, safety, and environmental information to users on an ongoing basis.
- The solvents industry is committed to protecting the environment and society as a whole by ensuring that solvents are used correctly from the beginning to the end of their life cycle.



### SOLVENTS: reliable partner in Europe

- ESIG actively supports its member companies in complying with all the relevant European legislation.
- The European solvents industry is thoroughly committed to safer products and processes and is actively contributing to make the new European chemicals legislation (REACH) effective and workable.
- ESIG is supporting its members in preparing for the required registration of hydrocarbon and oxygenated solvents by assembling all the technical information necessary for REACH.
- Under the new REACH legislation, all ESIG members have been asked to compile a set of scenarios covering all potential uses of solvents. ESIG has helped them by developing a Generic Exposure Scenario Library that contains the most common scenarios for solvent producers and users, together with instructions on how each substance can be safely used throughout its lifecycle.

#### SOLVENTS: contributing to economic and social welfare

- The solvents industry directly employs more than 10,000 people in Europe, but indirectly it accounts for more than 10 million jobs, with more than half a million European companies using solvents (ranging from pharmaceutical to agrochemical and paint producers).
- Solvents manufacturers across Europe have an estimated combined turnover of about €5 billion. Companies using solvents have a combined turnover of €200 billion.
